**Dear Building Permit Applicant:**

**Increased concern about proper handling of hazardous materials and hazardous wastes has prompted the California Legislature to pass a number of laws regulating these substances. Several of these recent bills require that businesses that handle these substances disclose this information to local government, to protect firefighters and other emergency responders.**

**A new law went into effect on July 1, 1989, requiring that this disclosure occur, before a building permit may be issued. The Health Department intends to carry out this new requirement in as simple and reasonable a fashion as possible. All non-residential building permit applicants, which include detached garages, barns and outbuildings, will be required to complete the disclosure on the reverse side of this document. This form must be completed by the business or property owner. A contractor may not “sign off” on this form for the owner, for the simple reason that he very likely will not know for what future purpose a building will be used.**

**Hazardous materials and wastes are very common and most of us have lots of them in our homes. They are as familiar as paint thinner, gasoline and waste oil. It is important that people recognize that these materials need to be used and stored carefully. If you will only have “normal” amounts of these materials, mostly prepackaged for consumer use, then you can check “no” on the disclosure form.**

**When you have completed the disclosure form, turn it in to the Environmental Health Department. The “Hazardous Materials” portion of your building permit will then be cleared. If you have questions, call (209) 223-6439.**
